Governor Cuomo announcement on school opening	New York State will decide whether schools will reopen in the fall during the first week of August. New York State is now consulting with stakeholders on guidance, which will be finalized on July 13. Plans to reopen schools are due on July 31.
Statement From Chancellor Betty A. Rosa, the Board of Regents and Interim Commissioner Shannon Tahoe	Official response to federal call for full opening. “Any decision on the reopening of school buildings should be made based on the best science, data and guidance available from state and federal health professionals.” The Department “will present guidance to the Board of Regents at its next meeting on July 13” after considering feedback from the task force meetings.
